PURPOSE/SUMMARY:

AN ORDINANCE CONFIRMING THE APPOINTMENT OF ELLEN BLAIR AS THE ACTING DIRECTOR OF EMPLOYEE SERVICES; WAIVING THE 60-DAY LIMITATION ON MAYORAL APPOINTMENTS TO FILL VACANT POSITIONS, AS SET FORTH IN SECTION 20.103, *ORDINANCE CODE*, TO ALLOW FOR THE FOREGOING APPOINTMENT TO BE EFFECTIVE UNTIL THE EARLIER OF DECEMBER 31, 2013, OR WHEN HER SUCCESSOR IS APPOINTED BY THE MAYOR AND CONFIRMED BY THE COUNCIL; REQUESTING EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.
