PURPOSE/SUMMARY:

Ordinance 2012-433-E, Part X, Section 10.1 requires that the Jacksonville Children's Commission return to City Council for approval of changes made to the Second Revised Schedule A-2 that was approved with the original ordinance. The Commission has worked in cooperation with the City of Jacksonville Procurement Division to re-bid its Community Based After-School Programs. As such, the amounts of estimated funding for certain agencies listed in the approved Schedule A-2 have changed. A revised schedule is attached to this fact sheet.
