The agreement is for the purpose of all parties to acknowledge and agree on terms for utilizing the P25 Radio System. The P25 Radio System network allows for additional customers and radios to be added onto the system and allows COJ opportunities to leverage our existing

City will provide Constitutional Officers/Independent Agencies and other local government entities daily access to the P25 Radio System for all P25 compatible radio units. The activated units will be billed on a monthly per radio unit. The Office of General Counsel has prepared the radio services agreement. We are requesting additional authority for the Mayor without having to go back to City Council and/or ITD Chief to execute similar form agreements with other third-party subscribers.
