PURPOSE/SUMMARY: The Planning and Development Department requests approval to initiate legislation adopt local administrative amendments to the Florida Building Code in Chapter 321 of the Jacksonville Ordinance Code. The proposed changes are for the purpose of developing a separate ordinance (Chapter 652 Re-write and Repeal) that complies with the National Flood Insurance Program and State of Florida Department of Emergency Management floodplain requirements. In addition, said proposed changes were reviewed and approved by the State of Florida Division of Emergency Management, and deemed in compliance with the State's Model Ordinance for Floodplain Regulations.
