PURPOSE/SUMMARY:

- Please provide the Real Estate Division with authority to request the legislation necessary for the City Council to approve the conveyance of eight Perpetual Easements and two Temporary Easements, in accordance with Section 122.421 (b), and authorize the Mayor and Corporation Secretary to execute all the necessary documentation to convey said Perpetual Easements and Temporary Easements to FDOT.
- The Perpetual Easements are for the purpose of constructing and maintaining traffic signal loops, pedestrian poles and signal equipment. The Temporary Easements are for the purpose of tying in and harmonizing property and driveways, walkways, etc.
- This project is for general maintenance of Dunn Avenue. It includes the addition of bike lanes, sidewalk renovations and intersection signal loop relocation at Busch Drive.
