PURPOSE/SUMMARY:

The proposed ordinance will amend the Met Park Lease, as attached in exhibit to 2013-676-E. The ordinance amends the Met Park Lease indemnity and insurance requirements to mirror those provisions as required under sections 191.105 and 191.106 of the Special Events Ordinance Code. For the reasons set forth in the Memorandum from Twane Duckworth, Risk Manager, and Tonisha Landry-Gaines, Special Events Chief, dated July 11, 2014, this amendment to the Met Park Lease reconciles the omission of updated indemnity language and insurance provisions pertinent to the typical operations associated with activities that occur at Met Park.
