PURPOSE/SUMMARY:

- Please provide the Real Estate Division with authorization to request legislation for City Council approval to close, abandon and/or disclaim a portion of Sprague Street, a 35' plated, opened and improved right-of-way in Westbrook Terrace (Plat Book 7, page 35, dated June 7, 1921).
- The closure will allow the owners, BSE Investments, LLC and SADS, Inc., to increase parking and security at their facilities located on both sides of Sprague Street.
- The adjacent properties are zoned "Light Industrial."
- BSE Investments, LLC and SADS Inc. own all the property adjacent to the requested closure.
- The applicant has paid the \$1,500.00 application fee.
