PURPOSE/SUMMARY:

To appropriate the first year of a five year 21st Century Community Learning Center Grant from the Florida Department of Education to provide afterschool programs at three elementary schools in Duval County. The three schools are Jacksonville Heights, Ramona and Windy Hill elementary schools. The grant period is September 1, 2014 - August 30, 2015; funds are awarded and appropriated annually. Also requesting a carryover of unspent funds into subsequent years as allowed by the grantor.
