- Please provide the Real Estate Division with authorization to request legislation for City Council approval to close, abandon and/or disclaim a portion of Ridgewood Road, a variable width plated, improved and opened right-of-way in St. Nicholas Park Shopping Center (Plat Book 17, Page 59),
- and to reserve an Easement for All Utilities in the name of the City and JEA.
- The applicant, Scott C. Miller, et.al., is requesting the closure to expand its commercial property.
- The applicant has paid the \$1,500.00 application fee.
- All adjacent property owners have been notified of the closure request.
- This closure request has been sent to the various State, municipal and utility agencies which might have an interest in this matter.
