PURPOSE/SUMMARY:

- and authorize the Mayor and Corporation Secretary to execute all the necessary documentation to convey said Temporary Construction Easement to the Florida Department of Transportation.
- The parcel is needed by FDOT for the replacement of Bridge #724171 at Newnan Street/Hubbard Street over Hogan Creek.
- Ordinance 2014-485-E authorized the "Construction and Maintenance Agreement" between the City and FDOT for the bridge replacement.
- The Temporary Construction Easement is for the purpose of tying in, harmonizing and resurfacing a portion of Newnan Street/Hubbard Street. The entire TCE is within right-of-way. A map is enclosed for your reference.
