PURPOSE/SUMMARY:

- Please provide the Real Estate Division with authority to request the legislation necessary for the City Council to approve the subordination of utility easements in one parcel along Atlantic Boulevard in accordance with Section 122.421 (b), and authorize the Mayor and Corporation Secretary to execute all the necessary documentation to subordinate the City's easement interests to the Florida Department of Transportation.
- The Florida Department of Transportation is acquiring right-of-way for the purpose of roadway construction on SR 10 (Atlantic Blvd.) which will include safety, drainage, transit and signalization improvements.
- Parcel 102.3 is being acquired by FDOT for right-of-way. The City of Jacksonville and JEA hold a 30' easement for sewer and water mains and a 35' drainage easement over the parcel. The parcel contains 253 square feet.
- This request has been approved by the Public Works City Engineer, Right-of-Way and Stormwater Maintenance and JEA.
