PURPOSE/SUMMARY:

- Please provide the Real Estate Division with authority to request the legislation necessary for the City Council to approve granting one (1) Perpetual Easement for Drainage in accordance with Section 122.421 (b), and authorize the Mayor and Corporation Secretary to execute all the necessary documentation to convey said Permanent Drainage Easement to the Florida Department of Transportation.
- The Florida Department of Transportation is acquiring right-of-way and easements for the purpose of drainage improvements on Mount Pleasant Road in the vicinity of McCormick Road.
- This Easement is for the purpose of constructing and maintaining stormwater drainage piping associated with the construction to be undertaken by FDOT.
- Parcel 800.1 contains 772 square feet and is within the right-of-way of the intersection of Mount Pleasant Road and Pleasantview Drive East. Maps are enclosed for your reference.
