PURPOSE/SUMMARY:

- Please provide the Real Estate Division with authority to request the legislation necessary for the City Council to approve the subordination of three (3) Permanent Easements for Drainage in accordance with Section 122.421 (b), and authorize the Mayor and Corporation Secretary to execute all the necessary documentation to convey said Permanent Drainage Easements to the Florida Department of Transportation.
- These parcels are needed by FDOT for improvements to Baymeadows Road at the intersections of Freedom Commerce Parkway, Old Baymeadows Road and Southside Boulevard.
- Parcel 102 contains 1,520 square feet and is within a parcel which FDOT is acquiring for right-of-way at the intersection of Baymeadows Road and Freedom Commerce Parkway Parcel 803 contains 2,117 square feet and is located at the intersection of Old Baymeadows Road and Paseo Drive East. Parcel 805 contains 2,029 square feet and is located opposite the intersection of Old Baymeadows Road and Baymeadows Road. These parcels will be used in the right-of-way improvement project.
