FACT SHEET REQUIRED BEFORE LEGISLATION IS INTRODUCED

Upon creation of the Office of Inspector General the funding was appropriated with a statement of unknown IT costs (see 2014-519E). The resulting budget authorized the expenditures to start up an office along with four full time staff. At the time of approval by the Council, the budget sub-object codes were not established. As such, according to the Budget office, the Office of Inspector General cannot move the money into the needed categories such as IT for computers, phones, and various IT needs.
