PURPOSE/SUMMARY:

- Please provide the Real Estate Division with authority to request the legislation necessary for the City Council to approve the conveyance of one (1) Fee Parcel and one (1) Temporary Construction Easement, in accordance with Section 122.421 (b),
- and authorize the Mayor and Corporation Secretary to execute all the necessary documentation to convey said Fee Parcel and Temporary Construction Easement to the Florida Department of Transportation.
- These parcels are needed by FDOT for the construction of interchange improvements at the I-95 and I-295 Interchange North and for improvements to Cole Road where it crosses under I-95.
- The Fee Parcel contains 1,929 square feet and is from the existing right-of-way of Cole Road West where it dead ends at I-95.
- The Temporary Construction Easement is for the purpose of roadway improvements to Cole Road and for tying in and harmonizing adjacent property, driveways, walkways, etc.
