PURPOSE/SUMMARY Please provide the Real Estate Division with the authorization to request the legislation necessary for the Mayor to execute a Sovereignty Submerged Lands Easement Renewal, BOT No. 160771382 from the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida. The purpose of this Lease is used solely for a Storm Water Outfall Structure. The term of the lease is for 50 years at no cost.

This is a 25'x20' Submerged Land Easement covering the River outlet end of a 48" storm drain. The drain line is located at the River end between 3255 and 3265 Front Rd. This storm pipe serves to drain Front Rd. and a portion of Beauclerc Rd., Beauclerc Terr.and the Pickwick Park Area.
