## PURPOSE/SUMMARY:

SPONSOR: Public Works / Real Estate

- Please provide the Real Estate Division with authority to request the legislation necessary for the City Council to approve the subordination of one (1) Perpetual Easement, in accordance with Section 122.421 (b), and authorize the Mayor and Corporation Secretary to execute all the necessary documentation to subordinate said Perpetual Easement to the Florida Department of Transportation.
- The City owns a large drainage right-of-way which crosses University Blvd. in the vicinity of the intersection of Barnes Rd. The ditch in this right-of-way drains a large area north west of University Blvd. and also takes runoff from Interstate 95.
- FDOT is acquiring a fee parcel over the ditch to correct erosion and slope failure and to improve maintenance access.
- The City holds a Perpetual Easement for the purpose of drainage and utilities over the fee parcel. FDOT is requesting that the City execute a subordination of this interest.
- This request has been approved by the Public Works City Engineer and Right-of-way and Stormwater Maintenance.
