PURPOSE/SUMMARY:

The Parks, Recreation and Community Services Department respectfully requests approval to initiate legislation to execute a Recreational Trails Program (RTP) grant agreement with the Florida Department of Environmental Protection to expand the paved trail system at Lonnie C. Miller Sr. Regional Park in Council District 10. \$200,000 will be transferred from CIP project and \$200,000 will be reimbursed by Grantor.
