PURPOSE/SUMMARY:

The CDI Company(CDI), a large engineering and IT firm which focuses on the aerospace and defense industries, would like to execute a new lease agreement for the city-owned building (Building 900) they currently lease, at Cecil Commerce Center. CDI, which has leased various buildings at Cecil Commerce Center since 2004. The Cecil operation handles the assembly of light electronic equipment for the aviation industry. Their current clients at Cecil include: NAVAIR, Warner Robins ALC and Boeing. The proposed lease agreement will expand CDI's footprint at Cecil by 1,000 SF (to 12,474 SF).
