PURPOSE/SUMMARY:

Please provide the Real Estate Division with authority to request the legislation necessary for the City Council to approve the closure and abandonment of the right-of-way of Dante Place, established in Plat Book 8, Page 3, Palm Park, dated March 20, 1922.

The closure is requested by Baptist Health Properties, Inc. for the construction of the Baptist/M. D. Anderson Cancer Center. All the property on both sides of the right-of-way is owned by the applicant. The applicant has paid the \$1,688.00 application fee.

There are multiple utility facilities in the subject right-of-way. The applicant's representative, England-Thims & Miller, Inc., will coordinate the removal and relocation of utilities with the various utility organizations. The removals and relocations of utilities will take place during construction of the medical facility. The enacted ordinance closing this right-of-way will will not be recorded until the various utilities have been removed and/or relocated to the satisfaction of each utility agency.
