This legislation is to establish a Jax Kids Book Club Education Trust Fund account in the General Trust and Agency Fund to collect and deposit donations, contributions, gifts of a monetary value as sponsorships for the purpose of paying vendors for printing and distributing books to children in the Book Club. It is requested that all funds placed in this fund be accounted for in a separate self-appropriating account. In addition, the CEO of the Commission, under the direction of the Board be authorized to solicit sponsorships and funds for contribution to this account and the CEO be authorized to make disbursements from this account under the direction of the Board.
