PURPOSE/SUMMARY:

To offer a 50% discount to City employees who currently park in City-owned and managed parking facilities downtown and pay through payroll deduction. The discount will be effective 10/1/16 and will be available on a first come-first served basis as there are waiting lists at some parking facilities. For the purposes of this ordinance, employees of the following outside agencies will be included as "City employees": Tax Collector; Property Appraiser, Clerk of the Court; Supervisor of Elections.
