On behalf of Fleet Management, I have form approved and recommend the execution of the attached Declaration of Restrictive Covenant ("Declaration") for property known as Jacksonville Fire Station #10 RE# 063907-0000 ("Site"). The Site is in City Council District 14, Council Member Jim Love. The Declaration of Restrictive Covenant is between the Florida Department of Environmental Protection ("FDEP") and the City of Jacksonville.
