PURPOSE/SUMMARY:

Please provide the Real Estate Division with authority to request the legislation necessary for the City Council to approve the granting of one (1) Perpetual Easement for drainage in accordance with Section 122.421 (b), and authorize the Mayor and Corporation Secretary to execute all the necessary documentation to convey said Subordinations to the Florida Department of Transportation.

This parcel is needed by FDOT for the widening of I-295 from the Dames Point Bridge to north of Pulaski Road to eight (8) lanes from four (4) lanes, for the purpose of maintaining the storm water management facility outfall system for I-295.
