PURPOSE/SUMMARY:

The Environmental Quality Division (EQD) is requesting approval of a contract, DEP Contract No. GC892, between the State of Florida Department of Environmental Protection Petroleum Restoration Program and the City of Jacksonville. The EQD has had this contract/grant for approximately 25 years. This contract will provide funding for EQD personnel to continue to manage the cleanup of petroleum contaminated sites within Duval County and surrounding counties as well.

The initial term of this contract shall begin on July 1, 2016 and will remain in effect until June 30, 2021. EQD will be provided a new Task Assignment each fiscal year through the end of the contract. For this reason, EQD staff are also requesting City Council's authorization for the Mayor, or his designee, to execute any extensions to the contract and subsequent Task Assignments as needed.
