SUBJECT: Hidden Stagecoach Car Wash PUD

### **Introduction**

Hidden Stagecoach Car Wash PUD is proposing to rezone approximately 3.76 acres from PUD to PUD. The site is located at the intersection of SR 13/San Jose Boulevard and Hidden Stagecoach Road, in Jacksonville, Florida. The property is currently undeveloped. The new zoning district is being sought to provide for an 11,016 square foot upscale, full service car wash.

### **Accessibility**

Access to the site will be provided via one proposed access point on Hidden Stagecoach Road. No access will be requested or permitted on SR 13/San Jose Boulevard since the distance between the intersection of Hidden Stagecoach Road and the northernmost driveway for the Mandarin Lutheran Church is too close to allow for an additional driveway.

### **Bicycle and Pedestrian Facilities**

Existing sidewalks are located on the east and west side of SR 13/ San Jose Boulevard. A sidewalk also fronts the entire length of the property on Hidden Stagecoach Road. The FDOT Bicycle Pedestrian Gap Study, dated April 2015, indicates this section of SR 13 has a Tier 1 bicycle gap prioritization, a bicycle LOS of D and a pedestrian LOS of E.

# **Planned Improvements**

FDOT has not programmed any capacity projects in the vicinity of the subject property.

## **Trip Generation**

Table 1 shows the trip generation based on the maximum development allowed using ITE's *Trip Generation Manual*, 9<sup>th</sup> Edition.

### **Roadway Capacity**

Table 2 shows the PM peak hour and maximum level of service volumes for SR 13 according to FDOT's 2015 Florida State Highway System Level of Service Report, dated September 2016.

The segment mentioned in Table 2 has sufficient capacity to accommodate the trips generated from the development, and FDOT does not identify any potential adverse impacts on SR 13/ San Jose Boulevard.
