Campers Inn Holding Corporation (CIHC) and Campers Inn Management Company, Inc. are evaluating Jacksonville as the site for its U.S. corporate headquarters and training center. CIHC is the holding company and parent for 17 operating companies including 15 Campers Inn RV dealerships. These subsidiary companies collectively employ 415 persons and are located in 9 states along the eastern seaboard. The company is evaluating consolidating and relocating its Corporate Offices from Kingston, New Hampshire to either Jacksonville, FL or Charlotte, NC. CIHC proposes to relocate 22 headquarters staffers within 36 months to, Jacksonville, at an average wage of \$66,098.

Campers Inn is seeking public investment through the Qualified Targeted Industry (QTI) Tax Refund program. The QTI incentive proposed is \$6,000 per job comprising \$4,000 at 150% State Average Wage plus a high-impact industry bonus of \$2,000 per job. The City portion of the QTI program is 20 percent of the award, or \$1,200 per job up to \$26,400, in total. The QTI award will be payable after the average wage and jobs created are verified by the Florida Department of Economic Opportunity over the proposed six year payout, beginning in 2018.
