The right-of-way is unopened and unimproved and contains no utility facilities. The City of Jacksonville has no need, present or future, for the right-of-way. All of Cynthia Place was closed in Ordinance 2006-109-E except this small parcel.

The application is made by Hassan Al-Khazrajy for the purpose of enlarging his residential property. The adjacent property owner was notified of the application for closure and has no objection. The adjacent property owner will receive the half of the right-of-way that is adjacent to his property. The applicant has paid the \$1,688.00 application fee.
