Grace Electronics, a New York-based aerospace manufacturing company, which manufactures wire harnesses and other electronic equipment for military aircraft, is considering a relocation of its headquarters and main manufacturing operations to a city-owned building at the Cecil Commerce Center. The company has been in business for over 25 years. Two years ago, the company established a satellite office in a small city-owned building at Cecil due to requests by some of its customers in the Jacksonville region, who wanted to have a place where they could inspect certain work products before they were completed. The company's current client list includes: Lockheed Martin, Northrop Grumman and BAE Systems.

Grace Electronics currently leases a 1,500 square foot building at Cecil Commerce Center. The proposed project would include the expansion into another city-owned building (Building #905) at Cecil, where the company would lease an additional 10,000 square feet, for a minimum of three years. The new facility would house most of the manufacturing operation. The additional 10,146 square feet of industrial space, would be leased at market rate (\$6.00 per SF). The total lease income for the City each year would be \$63,276.00

The company is seeking public investment through the Qualified Targeted Industry (QTI) Tax Refund program. The QTI incentive proposed is \$5,000 per job. Based on Grace's application, the 25 new jobs would qualify for this program. The City portion of the QTI program is 20 percent of the award, or \$1,000 per job, up to \$25,000 in total. The QTI award will be payable after the average wage and jobs created are verified by the Florida Department of Economic Opportunity over the proposed five year payout, beginning in 2018. The company is also seeking to enter in to a lease agreement with the city, for a portion of a city-owned building at Cecil Commerce Center. The lease includes 10,146 square feet on industrial space in Building #905 at Cecil Commerce Center. The base lease rate is \$6.00 a square foot (\$60,876.00 Annually) and \$2400.00 common area maintenace fee per year. Applicable State sales tax of 7% will be applied for both CAM and base lease payments.

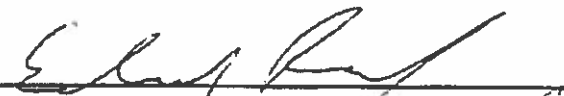
