This legislation as enacted will close, abandon and/or disclaim a portion of a 30 foot wide unopened and unimproved right-of-way established in Jacksonville Heights, Plat Book 5, Page 93, dated October 12, 1913, and located in Council District 12 within the Cecil Commerce Center, as shown in the attachments, with the revised legal description attached to this request.

The right-of-way is unopened and unimproved, but does contain infrastructure. Accordingly, an "All Utilities Easement" will be reserved in the name of JEA. There are no objections to this request from the State, Municipal and Utility agencies which may have interests in this right-of-way. The application is made by the Real Estate Division, and therefore no application fee is due.
