Please provide the Real Estate Division with authority to request the legislation necessary for the City Council to approve the closure and abandonment of a portion of a right-of-way in the vicinity of Hendricks Avenue and Nira Street.

The right-of-way to be closed is the southerly 142.66 feet of the right-of-way in Block 28, Oklahoma, Plat Book 2, Page 7. The northerly 377.34 feet of the alley was closed in Ordinance EE 633, dated June 7, 1963. The right-of-way contains infrastructure. Accordingly, an "all utilities easement" will be reserved in the name of the City and JEA. There were no objections from agencies which may have an interest in the alley. The City has no present or future need for this right-of-way.

The applicant, Florida Baptist Convention, Inc. owns the entirety of Block 28, Oklahoma and has paid the application fee of \$1,688.00.

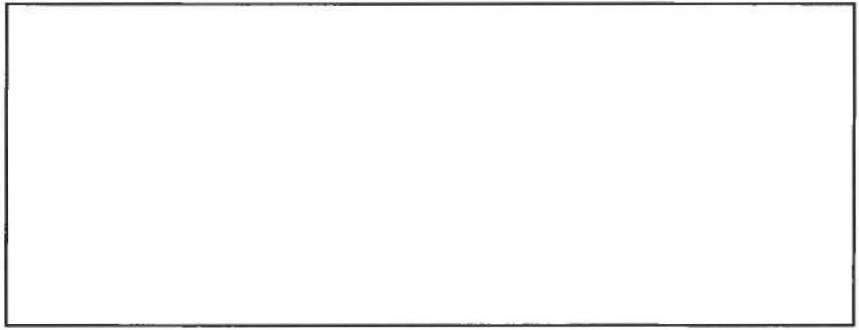
