Please provide the Real Estate Division with authority to request the legislation necessary for the City Council to approve granting one Non-Exclusive Utility Easement in accordance with Section 122.421 Ordinance Code, to Peoples Gas System, a Division of Tampa Electric Company (TECO), and authorize the Mayor and Corporation Secretary to execute all the necessary documentation to convey said Non-Exclusive Utility Easement to TECO.

This easement is for the installation and operation of a rectifier station on a parcel of land owned by the City of Jacksonville and used as a retention pond for Greenland Road. The rectifier station will be located on the eastern edge of the pond site and will not interfere with the operation of the drainage system. The facility will consist of a power pole, electric meter and rectifier and five ground rods. The easement will be approximately 10 feet by 200 feet, 2000 sqft. TECO will be charged a one time fee of \$2,360.00.
