PURPOSE: White Paper (Explain Why this legislation is necessary? Provide; Who, What, When, Where, How and the Impact.) Please provide the Real Estate Division with authority to request the legislation necessary for the City Council to approve the closure and abandonment of a portion of College Street, a 60 foot right-of-way, established in Plat Book 6, Page 5, First Addition to New Riverside, dated February 14, 1914 and FDOT Map Book E, Page 112. The portion to be closed is an irregular shape approximately 300 feet in length running east from its intersection with Willow Branch Avenue. It contains 5,531 square feet as shown on the attached survey.

There are no objections to this request from the State, Municipal and Utility Agencies which may have interests in this right-of-way. JEA has subsurface and overhead facilities in the right-of-way. Accordingly, an all utilities easement will be reserved in the name of JEA. The applicant anticipates relocation of those facilities, as necessary. The City of Jacksonville has no need, present or future, for the right-of-way.

The application is made by Curtis Hart, in anticipation of the residential development of the property (RE# 064616-0000) which lies south of the right-of-way. The applicant has paid the application fee of \$1,688.00.
