The property comprising Huguenot Memorial Park is jointly owned by the City of Jacksonville, the State of Florida, and the US Federal Government ("Department of the Army"). The City currently manages the State- and Federally-owned parcels through lease agreements (Lease Agreement No. 3101 and DA Lease No. DACW17-1-13-0002 respectively).

The Federal land lease (DACW17-1-13-0002) was just recently renewed until December 31, 2038 (legislation No. 2016-0471).

In July of 2016, the City started dialog with to renew State lease No. 3101, which expired on January 29, 2017

Lease No. 4790 (replaces State lease No. 3101) includes the property that was formally disputed between the State of Florida and the Federal Government. The lease period will be from January 30, 2017 to January 30, 2042, a 25 year lease. Legislation is needed to approve this lease.
