Dear Honorable Council President Brosche, Honorable Council Member and LUZ Chairperson Schellenberg and Honorable Members of the City Council:

Pursuant to the provisions of Section 30.204 and Section 656.129, *Ordinance Code*, the Planning Commission ("PC") respectfully offers this report for consideration by the Land Use and Zoning Committee ("LUZ").

- Recommendation by JPDD: Approve Deny
with the recommendation that the applicant amend the rezoning request to RLD-70.
- Recommendation by PC to LUZ: Approve Deny
- PC Vote: 6-0
- PC Commentary: Representatives from JAA spoke about their concern for new residential dwellings near a runway in the Cecil Commerce Center. The agent represented the northern portion of the site is mostly wetlands and the residential dwellings are in the southern portion outside the noise zone, but still in the Notice Zone.
The Commissioners agreed that most of the development will occur outside the noise zone.

The Commissioners felt there were similar sized lots in the area and voted to approve without the recommendation to amend the request to the RLD-70 Zoning district.
