The Planning and Development Department, Transportation Planning Division, requests approval to authorize the Mayor to execute a Memorandum of Understanding (MOU) between the City of Jacksonville (COJ) and the Florida Department of Transportation (FDOT) regarding the Mayo Foundation for Medical Education and Research's (Developer) fulfillment of Phase IV and Phase V concurrency requirement under its Development of Regional Impact (DRI) Notice of Proposed Change (NOPC). Per the Mayo NOPC amendments of 8/25/15, the Developer fulfills the Phase IV and V proportionate share contribution concurrency requirements by payment of \$2,593,000 to FDOT for a COJ-approved Department Work Program project. In 2016, FDOT proposed, and COJ accepted, a Department Project of a diverging diamond interchange conversion at State Road 202 (J. Turner Butler Blvd./San Pablo Road South interchange). FDOT has prepared a developer funded local agreement for the Developer's payment of its proportionate share contribution of \$2,593,000, requesting deposit of such funds by July 2017. FDOT will notify COJ in writing upon receipt of the Developer's proportionate share contribution. Such written notification to COJ will constitute the Developer's fulfillment of the Mayo DRI NOPC Phase IV and V requirements.




