The Real Estate Division, on behalf of the Engineering Division, requests the authority to submit legislation necessary to accept and execute an Easement Agreement with JEA and authorize the Mayor and Corporation Secretary to execute said agreement on behalf of the City of Jacksonville. Copies of the proposed easement are attached hereto.

The purpose of the Easement Agreement is to establish access rights and use parameters for the Hogan's Creek Greenway through the JEA property from Main Street to Laura Street. Two easement areas will be provided to the City from JEA. The easement area along the eastern border of Hogan's Creek will be used for the installation of an asphalt path, lighting, and landscaping. Construction funding is provided by FDOT. This easement ranges from approximately 15 feet to 25 feet wide. Along the western side of Hogan's Creek, the easement area will be used for bulkhead maintenance, if any is required. This easement area is 6 feet wide.
