Please provide the Real Estate Division with authority to request the legislation necessary for the City Council to approve the closure and abandonment of the 60 foot by 128 foot right-of-way of Canterbury Street, at the request of the two adjacent property owners, Leslie Kleisler and Jennifer Morgan. The right-of-way was established in Plat Book 19, Page 27, Scott's Replat of Lot 9, Fehrenback's Subdivision of the George Atkinson Grant, May 9, 1946. The right-of-way is unopened and unimproved and contains no infrastructure.

The applicants have requested the closure to increase their residential property, and have paid the \$2,091.00 application fee. Each of the applicants will inherit one-half of the property upon closure. Both are aware that they will be responsible for the maintenance of the property upon closure. There were no objections to the closure from City, State and utility agencies.


