Dear Honorable Council President Brosche, Honorable Council Member and LUZ Chairperson Schellenberg and Honorable Members of the City Council:

Pursuant to the provisions of Section 30.204 and Section 656.129, *Ordinance Code*, the Planning Commission ("PC") respectfully offers this report for consideration by the Land Use and Zoning Committee ("LUZ").

- Recommendation by JPDD: Approve Approve with Conditions Deny
- Recommendation by PC to LUZ: Approve Approve with Conditions Deny
- This rezoning is subject to the following exhibits:
 1. The original legal description dated October 23, 2017
 2. The **revised** written description dated April 26, 2018
 3. The **revised** site plan dated April 26, 2018

● Recommended Planning Commission Conditions* to the Ordinance:

1. ~~The proposed lots shall be a minimum of sixty (60) feet in width and at least 6,000 square feet in area.~~
2. The maximum lot coverage shall be 50%.
3. Prior to the first final inspection within any phase of development, the owner or their agent shall submit to the Planning and Development Department for its review and approval either (a) an affidavit documenting that all conditions to the development order have been satisfied, or (b) a detailed agreement for the completion of all conditions to the development order.
- 3.4. A shade tree, a minimum of 3 inches DBH (at the time of planting) shall be planted every 10 feet (within the 20-foot buffer along Grant Owens Road. Trees allowed to be used for mitigation are; Live oak, Red Maple, Sycamore, Loblolly Bay, Bald Cypress, Swamp Chestnut Oak, Catalpa, Southern Magnolia, Red Cedar, Leyland Cypress, River Birch, as well as any indigenous tree that reaches a height at maturity of at least 45 feet and a spread at maturity of at least 30 feet.

*Additions made by PC to the proposed Jacksonville Planning and Development Department (“JPDD”) conditions are underlined and deletions are indicated with a ~~strikethrough~~.

- Recommended PC Conditions that can be incorporated into the Written Description: None
- PC Vote: 9-0
- PC Commentary: There were no speakers in opposition.
The agent indicated he needed the smaller lots to pay for the additional pavement to access from Hogan Road. The agent indicated he is acceptable to the 50% lot coverage. The adjacent church requested an additional condition and the agent agreed.
