The purpose of this legislation is to authorize the appropriation of \$85,000.00 to settle a federal court lawsuit, the caption of which is Martin Chapman v. City of Jacksonville (the "Chapman, a former employee of the Jacksonville Sheriff's Office, filed a lawsuit against the City of Jacksonville alleging age and disability discrimination in violation of federal statutes.

Although the City has meritorious defenses, the Administration authorized OGC to attempt to settle the case to avoid lengthy and expensive litigation and uncertain outcomes.

On November 21, 2017, the parties settled the case for \$85,000.00, pending City Council approval.




