- PC Commentary: There were four speakers in opposition. The residents were satisfied with the current PUD conditions, which were agreed to by the community. They felt the developer was not responsive to their concerns. People moving to this area prefer single family homes not townhomes. There was a concern about the safety of children in the area and the new retention ponds. Runoff was also a concern.

Some Commissioners felt some of the issues were dealt with in the written description. One commissioner questions the need to increase the number of units.
