Please provide the Real Estate Division with authority to request the legislation necessary for the City Council to approve the closure and abandonment of an easement for drainage located on property south of the present termination of Brightman Blvd. The easement was granted in OR Book 12063, Page 446 and OR Book 12063, Page 470.

The abandonment is requested to facilitate the development of an apartment complex on the parent tract. The City does not have any responsibility for maintenance of the current drainage facility nor will it have responsibility for the future facility. The abandonment of the easement will not go into effect until a Professional Engineer certifies that the New Drainage Easement and New Pond Easement are in use and acceptable to the City. The Conditional Grant and Release of Easements in the form attached is being submitted to convey these interests.

The abandonment is requested by Thomas O. Ingram, Esq. on behalf of the property owner. The applicant has paid the application fee of \$1,066.00.

There were no objections to the closure of the drainage easement by Right of Way and Stormwater Maintenance and Public Works.


