Pursuant to the provisions of Section 30.204 and Section 656.129, *Ordinance Code*, the Planning Commission ("PC") respectfully offers this report for consideration by the Land Use and Zoning Committee ("LUZ").

• Recommendation by PC to LUZ: Approve Approve with Conditions Deny

• This rezoning is subject to the following exhibits:

• Recommended Planning Commission Conditions* to the Ordinance:

1. Driveway access shall align or meet separation requirements with existing driveway across Dunn Avenue (Dunn Avenue West office Park) or as otherwise approved by the Florida Department of Transportation (FDOT).
2. A traffic mitigation plan shall be submitted to the Planning and Development Department for review and approval at the time of Verification of Substantial Compliance of the PUD.
3. Prior to the first final inspection within any phase of development, the owner or their agent shall submit to the Planning and Development Department for its review and approval either (a) an affidavit documenting that all conditions to the development order have been satisfied, or (b) a detailed agreement for the completion of all conditions to the development order.

*Additions made by PC to the proposed Jacksonville Planning and Development Department (“JPDD”) conditions are underlined and deletions are indicated with a ~~strike~~through.

- Recommended PC Conditions that can be incorporated into the Written Description: None
- PC Vote: 9-0
- PC Commentary: There were no speakers in opposition and little discussion among the Commissioners.
