The AHU 4 is in need of replacement as it is currently non-functional and controls air circulation, conditioning, ventilation, and heating throughout a portion of the Police Memorial Building. Deferral of this amendment of the CIP until the next annual budget and CIP review will be detrimental to the best interest of the community because such deferral will result in the unnecessary delay of completing the needed repairs.
