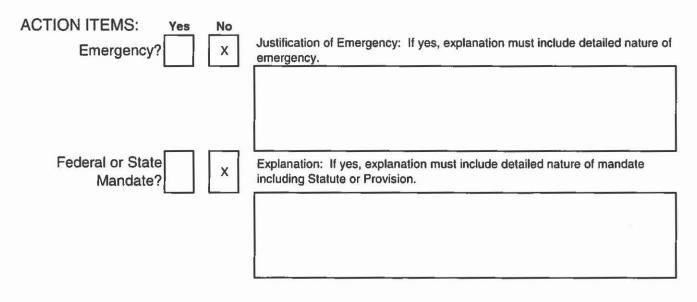

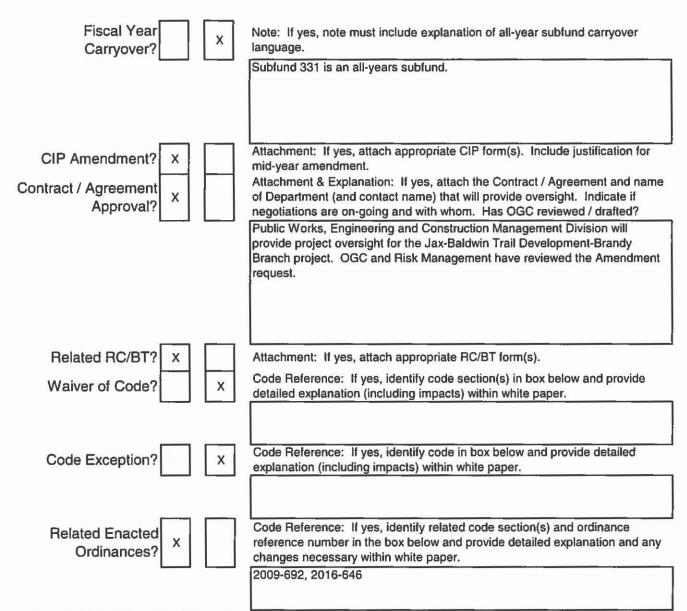

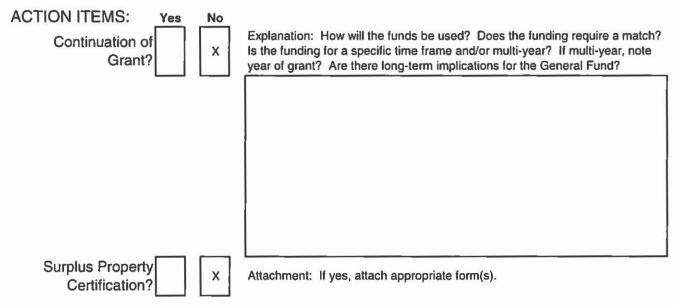
Project delivery utilized a Local Agency Program (LAP) agreement with Florida Department of Transportation (FDOT) to fully fund the Jax-Baldwin Trail Development-Brandy Branch project. The project currently has \$299,600 available for construction of this portion of the trail; however the bid is \$475,000.00. FDOT has agreed to provide additional funds to cover the shortage in order to award the project as bid. This request is to appropriate an additional \$175,400.00 from FDOT to fund the construction award and authorize the Mayor to execute the Local Agency Program Supplemental Agreement between the City and FDOT.
