The closure and abandonment is requested by Ozark Investment Group, LLC to maximize site development and create a communal town-center layout to maximize public walkability and safety. The right-of-way is approximately 50 feet by 300 feet. Ozark Investment Group, LLC owns the property on both sides of the right-of-way. The applicant has paid the application fee of \$2,091.00.

There were no objections to the closure of the right-of-way. The right-of-way contains JEA overhead and underground facilities and City drainage facilities. Accordingly, an all utilities easement with right of ingress and egress will be reserved in the name of JEA and the City of Jacksonville.
