PURPOSE: White Paper (Explain Why this legislation is necessary? Provide; Who, What, When, Where, How and the Impact.) The purpose of the appropriation is for disaster recovery purposes enabling the City to engage in the transformative neighborhood projects that will strengthen cultural and community leadership, reclaim blighted properties, improve the quality of life for residents, especially homeless and low-income residents, and grow community pride.

NEIGHBORHOOD RESTORATION

- (a) One of the hardest hit communities by Hurricane Irma was the Ken Knight Drive neighborhood of Washington Heights. The community was severely hard hit by the storm surge which brought waters from the nearby Ribault River into their homes. The unprecedented flooding also highlighted the need to update neighborhood infrastructure. The neighborhood is comprised of a very high-concentration of individuals and families at or below the poverty level who are renting costly and poor quality homes from absentee landlords or are residing in the nearby public housing development, Washington Heights. Due to both the past foreclosure crises and the recent hurricanes, the landlords did not make the needed repairs to their rental units and families are still residing in dilapidated homes with unsanitary conditions.
- (b) With the Embassy's Grant, the City, working with Recipients identified in paragraph 2.(b), above, will engage in transformative neighborhood projects to strengthen cultural and community leadership, reclaim blighted properties, improve the quality of life for residents, and grow community pride. More specifically, it is intended that the following projects be undertaken as described in the City of Jacksonville's April 13, 2018 proposal:
- (i) \$125,000 for Computer Labs at William M. Raines and Jean Ribault High Schools,
- (ii) \$525,000 for the Charles Reese Park Restoration,
- (iii) \$950,000 for the Ken Knight Drive Neighborhood Home Repair and Restoration,
- (iv) \$275,000 for Public Infrastructure on Ken Knight Drive.

DOWNTOWN HOMELESSNESS

(a) Local providers of services for the homeless together respond to the housing crisis of 5,000 to 8,000 of our neighbors every year. In the past three years more than 750,000 nights of shelter were provided. Over 3,000,000 meals and more than 100,000 medical and dental visits were also provided. As a result of the efforts of these providers to resolve homelessness, more than 2,250 households have moved into permanent housing, 1,500 veterans have been connected to jobs, and nearly 500 have recovered from drugs and alcohol addiction. The preliminary numbers from the 2017 Point in Time count show, on any given night, 1,800 of our neighbors experience homelessness. Of those 400 to 450 are unsheltered, living in their cars or on our streets. The Mayor called on these providers to recommend ways to increase access to services by homeless persons. They have developed a project concept to expand services and end homelessness for more homeless persons in the City's downtown core by increasing collaboration among the providers to give homeless persons an increased variety of entry points for access to services such as job and housing resource services, healthcare, disability application processors, and Veterans Administration services.

(h) The Embergu's generals great will enable the City working with the LM Sulzbeeber Center to design and build two

- A. The amount granted by the EMBASSY OF THE UNITED ARAB EMIRATES (the "Embassy") to the CITY OF JACKSONVILLE (the "City") is \$2,775,000.00 (the "Grant"). The Embassy designates the City as the local steward of the Grant. Any part of the Grant not disbursed in the manner described in this Agreement within one year after receipt of the Grant by the City shall be subject to other uses as mutually agreed between the Embassy and the City to carry out the Embassy's charitable intent.
- B. The City will use its best efforts to allocate the Grant among the following recipients, in the following amounts and for the purposes set out in the proposal submitted by the City on April 13, 2018, a copy of which is attached to this Agreement as Exhibit "A":
- (i) \$425,000 to Duval County Public Schools for its Construction and Architecture Career Academy and Computer Labs at William M. Raines High School and Jean Ribault High School;
- (ii) \$250,000 to Builders' Care for the Ken Knight Drive Neighborhood Home Repair and Restoration Project;
- (iii) \$400,000 to Habitat for Humanity of Jacksonville, Inc. for the Ken Knight Drive Neighborhood Home Repair and Restoration Project;
- (iv) \$900,000 to I.M. Sulzbacher Center for Mobile Medical Clinics; and
- (v) \$800,000 to the City of Jacksonville for the Charles Reese Park Restoration and Public Infrastructure on Ken Knight Drive.
- C. The City, the Embassy, and the funded partners listed above will agree on an appropriate form of recognition honoring the Embassy for its generosity toward the City's recovery efforts from the impacts of Hurricane Irma.
- (d) This Grant is intended by the Embassy and the City to benefit the citizens of the City as set forth above, and is not intended to, nor does it, constitute a gift or benefit by the United Arab Emirates to any official of the City or of the State of Florida.
