The Real Estate Division has received a request from Sharon L. Bennett to surplus the subject parcel RE# 000971-1250 and authorize its disposition to Ms. Bennett, the previous owner of record. This legislation is necessary for City Council to Waive Chapter 122, Part 4, Subpart B, Section 122.423 of the Ordinance Code, to declare the subject tax reverted parcel "surplus" to the needs of the City, and authorize its disposition to Sharon L. Bennett, in accordance with Section 197.592, Florida Statutes. A map of the subject parcel is enclosed for your reference.

The subject parcel is a tax reverted residential dwelling that reverted to the City on March 26, 2018. Section 197.592, Florida Statutes, authorizes the City to convey the property to the previous owner of record upon payment to the City for the amount of all taxes which had become delinquent at the time the property reverted to the City, plus interest and costs. The amount due is \$8,900.00, which has been paid.

The Real Estate Division has conducted an investigation of "need", as required by Section 122.422 and it was determined that the City of Jacksonville has no need to retain the parcel.




