- Recommended Planning Commission Conditions\* to the Ordinance:
  - 1. Under EXHIBIT D Part III. A. Permitted Uses, 21. Pawn shops with no outside display limited to items in the CCG-1 Zoning District shall be moved to B. Permissible Uses by Exception.
  - 2. The City's Traffic Engineering Division will review reductions in parking from Part 6 of the Zoning Code prior to issuance of building permits.
  - 3. Prior to the first final inspection within any phase of development, the owner or their agent shall submit to the Planning and Development Department for its review and approval either (a) an affidavit documenting that all conditions to the development order have been satisfied, or (b) a detailed agreement for the completion of all conditions to the development order.
