This legislation is necessary for City Council to authorize the Mayor to execute the attached License Agreement (Agreement) in substantially the same form with 13-JAX, INC. D/B/A Friends of Hemming Park (FOHP). This Agreement provides approximately 1,846.6 square feet of office space located on the ground floor of the Ed Ball Building, formerly the Victoria's Café space. The FOHP is being asked to leave its current space at the Main Library. The premises will be renovated for office space by the City at a cost of approximately \$57,500.00. FOHP will use the premises for its management and programming responsibilities found in the Operations and Management Contract approved by City Council in Ordinance 2014-434-E. The term of this Agreement shall commence upon the Effective Date of the Agreement and will last for twelve months and will become month-to-month thereafter. The Agreement may be terminated by either party at any time for any reason with sixty days prior written notice. The License Fee for the Premises is \$1.00 per term. Oversight of this Agreement is designated to Parks, Recreation, and Community Services.


